

**GENERAL PURPOSES PANEL.**

Minutes of meeting in County Buildings, Wellington Square, Ayr,  
on 1st September 2010 at 10.00 a.m.

**1. Requests for Civic Hospitality.**

There was submitted a report (issued) of August 2010 together with an addendum report (tabled) detailing requests for Civic Hospitality and Civic Hospitality which had been approved under delegated powers.

**Decided:**

- (1) to approve hospitality in connection with:-
- (a) Ayr Rotary Club – Hot Buffet and Refreshments, for approximately 100 guests in Ayr Town Hall on Wednesday, 23rd November 2010 at an approximate cost of £985; and
  - (b) Ayrshire Horticultural Society – Ayr Flower Show Golden Jubilee – Lunch for approximately 60 guests up to a maximum cost of £1,200 at a date to be confirmed;
- (2) to approve, in principle, hospitality in connection with:-
- (a) Lowland Reserve Forces' and Cadets' Association – Cadet 150 in October/November 2010;
  - (b) the Order of the Temple- The District Grand Priory of Ayrshire - Drinks Reception for approximately 100 guests up to a maximum cost of £1,700 during October/November 2010; and
  - (c) The 1st Battalion Scots Guards Homecoming Parade – Hot Buffet and Refreshments for approximately 500 guests in Ayr Town Hall on Thursday, 9th December 2010 up to maximum cost of £7,000;
- (3) to request that the Administration Manager (Corporate Services) investigate alternative funding for the Homecoming Parade for the 1st Battalion Scots Guards; and

- (4) to note the requests for Civic Hospitality approved under delegated powers as follows:-
- (a) Visit from Chernobyl Children – Light Buffet Lunch on Thursday, 12th August 2010 at an approximate cost of £495;
  - (b) The Great Tour – Circumnavigation of Great Britain by bicycle for Charity – Refreshments on Friday, 16th August 2010 at an approximate cost of £275;
  - (c) SOLACE Dinner – Drinks reception prior to meal on Friday, 20th August 2010 at an approximate cost of £70;
  - (d) RAF – 70th Anniversary of the Battle of Britain – Dinner on Friday, 10th September 2010 at an approximate cost of £2,337.50;
  - (e) Ayrshire Curlers plc – Relaunch of Ayr Ice Rink after refurbishment works – Finger Buffet on Monday, 20th September 2010 at an approximate cost of £928.50; and
  - (f) Crossroads – South Ayrshire – 25th Anniversary – Finger Buffet on Wednesday, 29th September 2010 at an approximate cost of £1,392.10.

## **2. Conferences and Seminars.**

There was submitted a list (issued) of August 2010 detailing a request for an attendance at a Conference and also attendances at Conferences which had been approved under delegated powers.

### **Decided:**

- (2) to note
  - (a) that Councillor Peter Convery had represented the Council at Putting Scotland at the Forefront Seminar in Edinburgh on Wednesday, 16th June 2010;
  - (b) that Councillor Helen Moonie had represented the Council at the NFLA Scottish Forum Seminar in Livingston on Friday, 18th June 2010;
  - (c) that Councillor Peter Convery would represent the Council at the Sustainable Municipal Waste Management in Scotland, Practical ways to meet the waste targets in Edinburgh on Tuesday, 7th September 2010; and
  - (d) that Councillor Robin Reid would represent the Council at the Infrastructure and Capital Investment in Scotland: Innovative ways to fund capital projects in Edinburgh on Wednesday, 3rd November 2010.

**3. Applications for Financial Assistance from Voluntary Organisations.**
